Light soil.....As high 100 to 1
Medium soil.....20 to 1
Heavy soil.....from 5 to 1 up to 20 to 1
Concrete, Kitchens, Engine Degreasing,
Machinery,
Power Washing: 1:100
Showers, Tank Degreasing.....1:10 up to 1:30
Painted Surfaces.....never less than 1 to 10
Windows, Mirrors,1 to 150
Use on vehicles through pressure washer
